General Notes

Each deactivation and discontinuance must be approved by the SUNY Provost.

If a proposed discontinued program is the sole program in a HEGIS disciplinary area at a campus, discontinuance requires approval of the SUNY Board of Trustees, but the campus retains its master plan authority in that HEGIS disciplinary area, and the re-introduction of programs in that HEGIS disciplinary area would not require a Master Plan Amendment.

Definitions

Deactivation: A campus decides not to admit any new students to a program but wishes to maintain the programs registration. This may be done to reassess the need for the program or restructure the program or allow currently enrolled students to graduate. This action is internal to SUNY and limited in duration to no more than three years, by which time the program must be reactivated or discontinued.

Deactivation Effective Date: The first regular admission date for which new students will no longer be permitted to enroll in the program.

Discontinuance: A campus decides to stop offering a program and awarding a credential for its completion. After SUNY's review and approval, the program is removed from the State Education Departments Inventory of Registered Programs after all continuing students have completed it.

Discontinuance Effective Date: The last graduation date for which a credential for completion of the program is awarded.

Students are unable to complete the program as originally intended due to a new inability to enroll in both an in-person, traditional MAT and, simultaneously, an online advanced certification add on. Additionally, NYS has discontinued grade bands for special education, the offerings in the program need to be restructured. Therefore, this program will be discontinued to make time and space to develop the new all grades special education program offerings.

Both the In-person (E88) and online (E88Z) Adolescence Advanced Certificate programs will be deactivated and then discontinued when the students finish. There are currently 5 students enrolled in-person and 1 online (6 total). Five of these should be finished at the end of the Spring 2026 semester, and the last student is expected to graduate in Fall 2026.
