The **Institute for Child Development's Child & Adolescent Diagnostic and Consultation Clinic (ICD-CADCC)** was established in 2017 and expanded in 2023 for the sole purpose of removing barriers to evidence-based and effective services in the local community. Our goal is to reduce lengthy wait times and the need for families to travel outside of the Southern Tier of New York to obtain high quality services from experts.

Our diagnostic and evaluation services are designed to help families understand if neurodevelopmental and learning differences are present in their child's profile so they can navigate how to help their child thrive by relying on their child's unique strengths. Formal diagnoses are assigned as an outcome of our evaluations, if applicable. We accept referrals from parents/legal guardians and/or school district representatives for children & adolescents ages 12 months through 17 years old. ICD-CADCC services are private pay. All fees must be paid at the time of service and can only be paid by check or money order.

We are not permitted by our overseeing campus fiscal administrator to accept insurance, cash, or credit card payments at this time. Families may request invoice documentation for their own self-claiming purposes.

Autism Diagnostic Visit – Autism only*

\$350

Designed for children and adolescents with cognitive and adaptive testing done within the prior year (often by school or county health dept) and only need testing for autism; records of prior testing must be available for review.

Includes ADOS & PDDBI

40-60 min appointment

Comprehensive Autism Evaluation– Autism only*

\$1000

Designed for children and adolescents who are exhibiting autistic symptoms and have either not had an evaluation at all or not been evaluated for special education/early intervention eligibility within the last year.

Includes ADOS & PDDBI, WISC/WPPSI*, Vineland

1-1.5 hour appointment

*May involve a different test if child is unable to complete structured intellectual battery

Comprehensive Differential Diagnosis Evaluation

\$1500

Designed for children and adolescents who are exhibiting symptoms that may indicate autism, anxiety, ADHD, mood problems, and/or similar syndromes and parents are looking to rule various diagnoses in or out.

Measures vary; diagnostic, cognitive, & adaptive

1.5-2 hour appointment

Comprehensive Differential with Learning Profile

\$2000

Designed for children and adolescents who may have autism, anxiety, ADHD, mood problems, and/or similar syndromes and possible learning disabilities in reading (dyslexia), writing (dysgraphia), and/or math (dyscalculia).

Includes Differential above plus achievement testing

Two 2-hour appts

Complex Comprehensive Neuropsychological

\$4000

Designed to evaluate above referenced childhood diagnoses as well as how the child/adolescent processes and organizes information to navigate life.

Includes testing listed for Differential w/ LP above & a neuropsychological battery appropriate for age

Three 2-3 hour appts

Frequently Asked Questions

How do we get started with services?

You can email icdcadcc@binghamton.edu and request a consent form for the evaluation type you would like to pursue. Please do not include any detailed information about your child in that initial email, just your name and contact information and what type of evaluation is desired. If you have questions or need clarification to know which type of evaluation is best to meet your child's needs, you can request that someone call you for assistance.

How do we submit the consent form?

You are permitted to email your consent form to us (if you prefer to do so), fax to us at 607-235-5172, or you can mail to us using the address on the consent form.

What happens after we return our signed consent form?

Evaluation referral consents are reviewed at the end of the month in which they are received. If your child's needs are believed to be appropriate for our clinic, we will email you with scheduling options. If your needs do not match with our clinical team's areas of competence, we will reach out to you and offer referral options.

What is the usual wait time to get an appointment?

We are usually scheduling out 3-4 months from the date a signed referral consent is received. However, wait times may be shorter or longer depending on referral volume at any given moment.

How long does it take to get the results of the evaluation?

Our clinical team typically debriefs parents at the end of each appointment so there is a working shared understanding of what was found at each point of testing. The final report is usually ready about 2 weeks after the last appointment your child has with us. This timeline can be affected by holidays/facility closures.

Can ICD-CADCC submit claims to my insurance company on my behalf?

Unfortunately, we cannot be involved in any aspect of the claiming process other than providing you with documentation of your paid invoice so that you can submit claims to your insurance company on your own. It can be helpful to discuss a preauthorization with your child's pediatrician *before* your appointment with us, as some insurance companies require physician preauthorization for reimbursement of self-claimed services when seeing out-of-network providers.

What if I cannot afford the cost of the evaluation my child needs?

We cannot authorize payment plans, but financial aid options may be available. Request information about financial aid support when you submit your consent and additional information will be sent to you about options.
