INTRODUCTION

This overview complements our analysis of recent country reports to the Convention on the Rights of Persons with Disabilities and related conventions from the UN's least developed countries. Our initial report, Barriers and Successes to Implementing the Convention on the Rights of Persons with Disabilities: An Overview of the UN's Least Developed Countries, identifies and discusses competing models of disability that shape approaches to the rights of disabled persons, the conditions that limit the capacity to protect and exercise those rights, creative partnerships and initiatives that advance rights and services in LDCs, and the potential for youth activism.

Although the country reports rarely mention specific civil society partners, in this report we highlight organizations in each LDC which appear explicitly or likely to contribute to advancing these rights and services. Contact information, overviews, and mission statements are provided where available.
