*Teaching Evaluations:

From Fall Semester 2007 to present student evaluations of my teaching have averaged above 3.97 on a scale of 4.0, including numerous course sections in which the class rated it at the 4.0 level. Further, in Fall 2011, Fall 2013, Fall 2014, Spring 2015, and Fall 2015 all courses taught during these respective semesters were evaluated at 4.0 on a 4.0 scale. (This is significantly above School's average of 3.2.). During this time enrollment in my graduate courses approximated 40 students per section and in my undergraduate courses it approximated 25 per section.

The level of student evaluations placed me onto the Dean's List for Excellence in Teaching for 20 straight semesters.
